1. <u>Information for Participants – Hotel</u>. Twenty rooms have been set aside in the name of Miller & Company P.C. at the <u>Raphael Hotel</u> in Kansas City, Missouri. The Hotel is located directly across from the Country Club Plaza and is only three blocks from our office.
