#### **ASSISTS/ROYALTIES**

Customs Office of Strategic Trade (OST) will soon begin sending letters and publications to importers explaining assists/royalties. Clients should recognize that the area of assists/royalties can be highly technical in nature; it is desirable to proceed cautiously. The presence or absence of a particular fact may change the dutiable consequences of a transaction. For more information contact Marshall Miller.

# **FOCUSED ASSESSMENT**

Customs Regulatory Audit has developed a new process to be announced soon. Questions and a written evaluation will be asked concerning a firm's internal controls over the import/export process. Clients without comprehensive internal controls over the import/export process including a Compliance Manual are encouraged to take action now.

# **NEW CAT KIT**

Customs posted a new CAT Kit that supercedes the Aug. 1999 version. It incorporates the changes announced by Customs in late 2000 at its Trade Symposium. New items include the exclusion of certain ultimate consignee imports and informal entries from Compliance Assessments, revised risk assessment procedures, and a guide for supporting GSP claims. #### **CHINA MFN/PNTR**

#### DRAFT ENTRY DIRECTIVE

# **BANANA WAR RESOLVED**

USTR announced on April 11 that it reached an agreement with the EU to resolve the banana trade dispute. The EU is expected to implement a new banana trade regime on July 1, 2001; then the U.S. would suspend its sanctions. Access "What's New" on our website.

#### **HMT REFUNDS**

Customs has issued a proposed rule for administratively handling all Harbor Maintenance Taxes paid on exports that are to be refunded pursuant to the Swisher Int'l v. U.S. case. The new rule provides for refunding HMT paid on exports back to inception of the HMT in 1987 with minimal filing requirements for exporters, including no requirements for supporting documentation for payments after July 1, 1990. Export HMT requests must be filed before the effective date of this proposed rule, which could occur shortly. Payors of export HMT who have not already requested refunds are encouraged to contact the firm immediately. 66 Fed. Reg. 16854 (Mar. 28, 2001).

# **FDA INADMISSIBLES**

Customs has issued T.D. 01-26, a final rule effective April 27, 2001, that is intended discourage the illegal sale of imported merchandise not meeting FDA standards by increasing the size of liquidated damages. 66 Fed. Reg. 16850 (Mar. 28, 2001); T.D. 01-26 (Mar. 8, 2001).

#### REVISED FTSR

#### NAFTA

- The implementation of NAFTA duty deferral provisions in Mexico continues to complicate the calculation of duties on certain parts. The PROSEC program implemented by the Mexican government covers 20 different industrial sectors by reducing the duty rates on inputs covered by specific HTS numbers. However, last month Mexican government unilaterally removed hundreds of HTS numbers from the program. This is a situation that must be constantly monitored.
- The Bush Administration has announced that it is opening the borders to Mexican trucks as required by the NAFTA in early 2002. There has been a long delay in the implementation of this provision due to concerns by the former Clinton Administration regarding safety issues. Expect lower freight rates on merchandise shipped from Mexico.

## **ANTIDUMPING**

USTR has requested comments on the U.S. response to WTO recommendations and rulings regarding the Antidumping Act of 1916. Last October the U.S. agreed to implement the W T O rulings and recommendations by July 26. 66 Fed. Reg. 15517 (Mar. 19, 2001).

#### **PRISON LABOR**

Customs announced the first criminal conviction of a Chinese company in a prison labor case. Binder clips assembled by prison labor in China were exported to the U.S. by Allied International Manufacturing Stationary Co., Ltd. (AIMCO) located in Nanjing, China to its sister company Officemate International Corporation (OIC) of Edison, NJ and its customers. **AIMCO** pleaded guilty and was fined \$50,000; OIC paid Customs \$500,000 in settlement of any potential civil charges.

#### **GSP**

- In its FY2002 budget, the Administration is proposing a one year extension of GSP, which is due to expire on 9/30/01. Expect another battle. Contingency plans for higher Customs duty payments should be formulated. www.whitehouse.gov/news/usbudget/blueprint/blueprint.pdf.
- The USTR has announced its annual GSP Product and Country Eligibility Practices review. Petitions for the 2001 review must be submitted to the USTR by 5:00 pm on June 13, 2001. 66 Fed. Reg 19278 (Apr. 13, 2001).

## **TRADE BARRIERS**

The US has issued its 2001 National Trade Estimate (NTE) Report on Foreign Trade Barriers, which identifies foreign barriers to US exports. <a href="www.ustr.gov/html/2001">www.ustr.gov/html/2001</a> contents.html.

## **PEA QUARTERLY REPORT**

For those importers who chose to amend eligible entries by filing a post-entry summary amendment (PEA) on a quarterly basis, the first quarterly report is due April 16. The report must be created using Customs' database, which is available at <a href="https://www.customs.gov/impoexpo/postamend.htm">www.customs.gov/impoexpo/postamend.htm</a>. The report can be forwarded by email or diskette to the port where the summaries being amended were filed.

#### SUMMIT OF THE AMERICAS

Expect another Seattle-like episode in Quebec City on April 22 when leaders of 34 countries A significant level of meet. planning has occurred for many months by groups seeking to disrupt the meetings and create demonstrations in the U.S. and elsewhere. The third Summit of the Americas will see President Bush push hard for FTAA quick finalization. One new development is the reluctance of Brazil, the largest country in South America, where current duty rates average 4 times the U.S. average, to become part of the agreement. The entire FTAA market is modest; U.S. exports to the area last year were \$59 billion, or 7.7% of total shipments.

#### **TEXTILE/APPAREL**

The Customs New York Strategic Trade Center (STC) has recently announced two efforts to boost compliance in the area of textiles/apparel. The separate efforts are directed against importers of fabrics and waterresistant apparel. ADM 01-0360 (Mar. 19, 2001) (fabric); ADM 01-0427 (Apr. 6, 2001) (waterresistant apparel).

#### ACS/AES
