## **USMCA IMPLEMENTATION**

- On March 13 the Canadian Parliament passed legislation to the U.S.-Mexico-Canada Agreement (USMCA). This final Canadian approval by the government starts a three-month period before the agreement can be implemented. The Trump Administration is said to be pushing for implementation in June. Quick implementation will require producers, exporters, and importers to rush to ensure their products are eligible for preferential treatment at the time of entry. The higher regional value content requirements for some products may require sourcing changes.
- The USMCA uniform regulations need to be issued before the agreement goes into effect. That could delay implementation. The three customs agencies will be scrambling to complete the regulations.
- The uniform regulations are necessary for companies to understand how many aspects of USMCA will be interpreted, including new rules of origin, inventory management methodologies, and origin marking requirements.
- CBP has created a USMCA webpage with basic information and FAQs.

#### FTZs & China 301 List 4A

In an unusual determination solely by CBP administrative message and without a CBP ruling, legal determination, or court case supporting the decision, CBP directed that China 301 List 4A material originally admitted to an FTZ as mandated in Privileged Foreign (PF) status at a 15% rate of duty may not utilize the 7.5% rate of duty now in effect on the date of FTZ withdrawal. This is different treatment than directed by the White House and Commerce Department duty reductions and/or elimination in Section 232 Trade Remedies. further Expect

#### **LIST 1 EXCLUSION EXTENSIONS**

On March 2, 2020, the U.S. Trade Representative (USTR) announced process for requesting extensions to China Section 301 List 1 product exclusions granted on May 14, 2019, and set to expire on May 14, 2020. Extension requests may be submitted for a thirty (30) day period from March 12 to April 12. Additional details are available here. ## **301 EXCLUSION REVISIONS**

- On February 20, the USTR announced three revisions previously-approved China Section 301 List 3 product exclusions. Two of the revisions expand the scope of existing product exclusions. The previously-approved exclusion for dog and cat collars is now limited only to dog collars. 85 Fed. Reg. 9921 (Feb. 20, 2020).
- On February 25, the USTR announced two revisions to the China Section 301 List 2 product exclusions. A new product exclusion was created for electric skateboards

## **COVID-19 TRADE IMPACT**

- · On March 11, 2020, President Trump announced further limitations on the entry of non-U.S. citizens and lawful permanent residents arriving in the U.S. from the 26 European country "Schengen Area." The UK and Ireland were added to the country list on March 14. This is in addition to prior travel restrictions China on Iran. These restrictions currently impact travelers and do not prohibit importation limit the οf merchandise from these countries. 85 Fed. Reg. 15043 (Mar. 16, 2020).
- · On March 13, CBP conducted a conference call on COVID-19 (coronavirus) impact. CBP has not had any staffing impact yet, but more personnel will be "teleworking" and officers with suspected exposure will be in 14-day quarantine.
- Remember that arriving merchandise may be "temporarily deposited" in a foreign-trade zone if Customs entry details or personnel are not available. It may also be regularly admitted into an FTZ.
- The United Nations Conference on Trade and Development (UNCTAD) has estimated that exports from China have declined by at least \$50 billion as the result of the coronavirus outbreak.

## **COVID-19 301 EXCLUSIONS**

Perhaps not coincidentally, the U.S. Trade Representative (USTR) has issued product exclusions covering medical products.

- · On March 10, the USTR announced the first list of China Section 301 List 4A product exclusions. These product exclusions are set forth in eight (8)ten-digit HT SUS classifications. 85 Fed. Reg. 13970 (Mar. 10, 2020).
- On March 12, the UST R announced additional China Section 301 List 3 and List 4A product exclusions set forth in five (ten-digit) classifications

## Section 301 Airbus Dispute

- · On February 21, the U.S. Trade Representative (USTR) announced revisions to the existing Section 301 duties imposed on certain EU products. Effective March 18, the applicable duty rate for certain new aircraft will increase from 10% to 15%. Some changes to product coverage went into effect on March 5. A more detailed explanation is available here. 85 Fed. Reg. 10204 (Feb. 21, 2020).
- The USTR has issued ministerial corrections to this product list. 85 Fed. Reg. 14517 (Mar. 12, 2020).

## Lacey Act de MinimIs

The Animal Plant Health Inspection Service (APHIS) has issued a Final Rule, effective April 1, 2020, that creates a de minimis standard for Lacey Act declarations. All clients importing materials subject to the Lacey Act should carefully review the new rules. The primary exception is for products containing materials that are no more than 5% of the total weight of the product, provided that the total weight of the plant material does not exceed 2.9kgs. ## **WTO Appellate Body**

# **CBP IPR BLOCK CHAIN TEST**

CBP has issued a report on a recent "proof of concept" use of block chain **IPR** management purposes. There are many technical concerns with using block chain verification for IPR at Customs entry, so it likely will be some time before block chain is available for this purpose.

#### FORD TARIFF ENGINEERING

Ford has filed a Petition for a Writ of Certiorari with the U.S. Supreme Court to appeal the CAFC's 2019 decision on the classification of Ford Transit vans that were declared as passenger vehicles and modified post-importation for use as cargo vehicles. ## **SECTION 232 TARIFF SCOPE**

- · On February 21, the CIT issued an Order blocking the Section 232 tariffs on aluminum and steel product derivatives for a second importer. Oman Fasteners, LLC v. U.S., Case No. 20-cv-00037 (Feb. 21, 2020).

#### **SECTION 232 LITIGATION**

The Court of Appeals for the Federal Circuit (CAFC) has upheld the U.S. Court of International Trade (CIT) ruling that Section 232 steel tariffs are a constitutional delegation of legislative authority, relying on and refusing to distinguish Supreme Court precedent. A petition seeking U.S. Supreme Court review is expected. American Inst. for Int'l Steel v. U.S., CAFC Slip Op. 2019-1727 (Feb. 28, 2020).

# CTPAT QUESTIONNAIRE

The firm has developed a new business partner questionnaire for its Customs Trade Partnership Against Terrorism (CTPAT) supply chain security program. ## **CBP TRADE STATISTICS**

As of March 4, CBP has assessed \$59 billion in Section 201, 232, and 301 duties. This includes \$47.8 billion in China Section 301 duties, \$335 million in EU Section 301 duties, and \$8.8 billion in Section 232 duties on aluminum and steel. \$1.6 billion has been collected in Section 201 duties on washing machines and solar cells.

## **Transaction Value**

#### **COVID-19 EXPORTS**

For researchers and companies engaged in COVID-19 research, the Bureau of Industry and Security (BIS) posted guidance on February 25 that the causative agent of COVID-19, the SARS-CoV-2 virus, is classified EAR99, even though the "SARS-related coronavirus" has an Export Control Classification Number (ECCN) of 1C351.a.46. As EAR99 classified, an export license is not required to most destinations, but end use and end user restrictions must still be considered. Contact Sean Murray or Chuck Ballard with questions.

#### **COUNTERFEIT SEIZURE**

The Court of Appeals for the Federal Circuit (CAFC) has ruled that butane gas cannisters had a counterfeit UL certification mark at importation even though the importer obtained approval for the UL mark postimportation. ICCS USA Corp. v. U.S., CAFC Slip Op. 2019-1561 (Mar. 11, 2020).

#### **ALUMINUM SHEET AD/CVD**

An aluminum industry group has filed petitions with the II.S International Trade Commission antidumping countervailing duties (AD/CVD) on common alloy aluminum sheet from 18 countries, including Germany, India, Korea, and Turkey. 85 Fed. Reg. 14702 (Mar. 13, 2020).

## **HUAWEI GL**

On March 12, the BIS published a Final Rule announcing it was extending to May 15 the General License (GL) for Huawei shipments necessary for the operation of existing networks or support of current mobile services. The BIS also requested comments by March 25 relating to further extensions of the GL. 85 Fed. Reg. 14416 and 14428 (Mar. 12, 2020).

#### **HUAWEI IRAN EXPORTS**

#### **RUSSIAN & YEMEN EXPORTS**

The BIS has issued a Final Rule Sean controlled for Nuclear 2020). Proliferation (NP) reasons Russia. Items controlled for NP1 reasons now require a license for export to Russia. Applications for licenses for items controlled for to Missile Technology (MT) or Chemical and Biological Weapons (CB) will be reviewed with a presumption of denial. Changes were also made for Yemen, moving it from Country Group "B" to Country Group "D." 85 Fed. Reg. 10274 (Feb. 24, 2020); 85 Fed. Reg. 13009 (Mar. 6, 2020).

#### LIQUIDATION EXTENSIONS

#### **VENEZUELA**

- On March 12, the Office of Foreign Assets Control (OFAC) announced changes to two General Licenses GL 15C authorizes transactions with some financial institutions and GL 16C authorizes personal accounts and transactions with some financial institutions.
- OFAC has issued GL 36A to permit Designated Nationals (SDN) List. wind down operations with Rosneft Trading S.A. and TNK Trading International S.A through May 20, involved in transactions related to Venezuelan oil sales. OFAC also issued two frequently asked questions (FAQs) on GL 36A: FAQ 817 and 818.

## **ACQUIRING U.S. TECHNOLOGY**

The Department of Defense (DoD) has issued a report describing attempts by foreign governments and entities to obtain technology.

The Department of Justice (DOJ) has announced a settlement with Chancery Staffing Services (CSS) for discriminating against non-U.S. citizens for positions related to International Traffic Regulations (ITAR) work. The DOJ argued that the ITAR does not specifically prohibit non-U.S. citizens from doing ITAR-related work so long as they obtain a license prior to the release of ITAR controlled information. Under the terms of the de settlement, CSS paid \$27,000 in penalties and agreed to upgrade their guidance and procedures.

## **Tit anium Sponge**

President Trump has determined not to impose Section 232 duties on titanium sponge imports. Presidential memorandum that titanium sponge is being imported into the U.S. in such quantities and under such circumstances as to threaten and impair national security, but 94.4% of the imports are from Japan, which has an important security relationship with the U.S. As a result, the President concurred with the Commerce Secretary's recommendations not to take actions to adjust imports under Section 232 at this time and to create a working group.

#### WTO Procurement Agmt

Rumors abound that USTR Robert Lighthizer is exploring U.S. withdrawal from the WTO Government Procurement Agreement. If the U.S. withdraws, it will limit consideration of products from foreign signatories to the WTO agreement in U.S. government procurements, but also impact U.S. firms competing for foreign
