#### **NAFTZ CONFERENCE**

(CBP) and the Foreign-Trade Zones Board (FTZB) made several important announcements at the National Association of Foreign-Trade Zones (NAFTZ) annual conference in Miami on September

·CBP Regulations. CBP will soon announce a working group to update the CBP Foreign-Trade Zone (FTZ) regulations in 19 C.F.R. Part 146.

Labor. CBP determined that FTZs cannot be used to store material under CBP Uyghur Forced Labor Prevention Act (UFLPA) detention.

Public Utility. The FTZ Board Executive Secretary reminded that FTZ Act "public utility" standards must be adhered to.

·FTZ Grantee Fees. The FTZ Board Executive Secretary made it clear that all fees charged by Grantees must be based on a "cost recovery" standard.

·CBP Staffing. CBP indicated several times that CBP staffing levels are significantly strained at many ports. While the Reimbursable Services Program (RSP) has recently been identified as a potential solution, it only covers overtime and does not fund additional CBP officers.

·User Fee Facilities. described User Fee Facilities as an option to support FTZ projects where there is no Customs Port of Entry.

Fentanyl. CBP's highest priority is interdicting fentanyl and precursor chemical imports.

·Section 321 Imports. Expect a significant regulatory clampdown on Section 321 imports. There are a wide range of legislative efforts in Congress that would impact Section 321 imports.

·FTZ Weekly Estimate 3461s. CBP emphasized that FTZ Weekly Estimate 3461 Cargo Releases require all entry line-item combinations (HTSUS, MID, and origin) for goods entered from FTZs. Contact Marshall Miller or Linda King with auestions.

# **FTZ BOARD ANNUAL REPORT**

The FTZB has published its annual report to Congress, providing FTZ statistics for 2022. The statistics indicate an increase in all categories except the number of FTZs, which remained at 197. Significantly,

#### **MORE RUSSIAN SANCTIONS**

On September 14, the Office of Foreign Assets Control (OFAC) added more than 150 individuals and entities to the Specially Designated Nationals (SDN) List for their involvement in supplying Russia with controlled goods or otherwise aiding the government. Sanctioned entities include Russian metal companies, vehicle manufacturers, and financial institutions.

State Department ·The designated 37 entities in the Russian energy sector, 7 entities in the minerals and mining sector, 11 entities that provide weapons repair and maintenance, Turkish entities that have provided material support and supported sanctions evasion, and others.

#### **U.S.-CHINA RELATIONS**

The Commerce Department has announced a new initiative with the Chinese government to establish a working group to seek solutions on commercial issues and advance U.S. commercial interests in China. The two governments also agreed to export exchange control enforcement information, hold discussions on the protection of trade secrets and confidential business information, and communicate regularly commercial and economic issues.

# **U.S.-JAPAN-KOREA**

The U.S., Japan, and Korea have announced a series of collaborative efforts, including efforts to address diversion of dual use technologies and criminal export controls.

# **OCEAN HOUSE BOLS**

CBP has announced the removal of the Ocean House Bill Release from merchandise received into FTZs the ACE Certification Environment increased over 20% to surpass \$1 because the go-live for Ocean

#### **NEW TRUMP TARIFFS?**

Former President Trump has suggested that, if elected, a 10% tariff would be immediately implemented on all products from all countries. Clients should take this into consideration for 2024 planning.

#### **UFLPA ENTITY LIST**

Chinese printer cartridge company Ninestar Corp. and eight subsidiaries have filed a complaint in the U.S. Court of International Trade (CIT) challenging their inclusion on the UFLPA Entity List by the Forced Labor Enforcement Task Force (FLETF) without providing any rationale. Ninestar Corp., et al. v. <u>U.S.</u>, CIT No. 23-00182.

### **FORCED LABOR TESTING**

CBP has released data showing only 15% of garments selected for isotropic testing, which can indicate the geographic location of cotton, were barred from entry into the U.S. under the UFLPA. The data showed that from December 2022 to May 2023, 13 of 86 garments selected for testing were composed of cotton from China's Xinjiang region. CBP commented that the small sample size is because isotropic testing is not yet a routine process.

#### **REDELIVERY NOTICES**

CBP has approved a Protest that challenged two Redelivery Notices which required redelivery without identifying the reason, finding them legally insufficient even though some of the redelivered merchandise was subsequently detained under the Withhold Release Order (WRO) for Malaysian disposable rubber gloves. HQ H328699 (July 3, 2023).

### **TUNA FORCED LABOR**

The National Oceanic Atmospheric Administration (NOAA) has issued a report to Congress that alleges the use of forced and child labor in China and Taiwan tuna fishing.

# **FORCED LABOR IPO**

Sixteen state attorneys general (AGs) have asked the Securities and Exchange Commission (SEC) to prevent SHEIN and other foreignowned firms from being publicly listed on the U.S. stock exchange until they have provided SEC certification of full compliance with the UFLPA. The AGs also noted SHEIN's use of de minimis entries to bypass CBP scrutiny.

#### 232 PROPOSED RULE

The Bureau of Industry and Security (BIS) has published a Proposed Rule to improve the processes for Section 232 exclusion requests and objections. General Approved Exclusions (GAE) criteria would consider HTSUS classifications with very low rates of successful objections and General Denial Exclusions (GDE) would be HTSUS implemented for classifications with a high rate of successful objections. Requestors and objectors would need to meet additional requirements. Comments are due by October 12. #### 232 EXCLUSION CHALLENGE

The U.S. Court of International Trade (CIT) has ruled that it possesses authority under its residual jurisdiction to hear a challenge to Section 232 steel product exclusions denied by the Commerce Department even though the plaintiffs' Customs entries are finally liquidated. The CIT remanded for Commerce reconsideration, and Commerce may instruct CBP to reliquidate entries that had not finally liquidated when the product exclusion requests were denied. AM/NS Calvert LLC v. U.S., CIT Slip Op. 23-129 (Sept. 6, 2023).

# WTO SECTION 232 DECISION

A World Trade Organization (WTO) dispute panel has rejected China's claim that its retaliatory tariffs against the U.S. Section 232 steel and aluminum tariffs were justified.

# **301 PRODUCT EXCLUSIONS**

USTR has issued a Notice extending the 77 existing COVID-19 related Section 301 product exclusions and 352 previously reinstated exclusions to December 31. 88 Fed. Reg. 62423 (Sept. 11, 2023).

# **DEEMED EXPORT AO**

has <u>released</u> an Advisory Opinion (AO) that some controlled technology can be released to a foreign national working temporarily in the U.S. when the U.S. company already has a license to release the product to its foreign parent.

### **RUSSIAN PROCUREMENT**

BIS has <u>issued</u> a Temporary Denial against (TDO) three individuals and four companies for allegedly being part of a Russian procurement scheme to obtain U.S. products and technology in support of the Russian military. 88 Fed. Reg. 61499 (Sept. 7, 2023).

#### TRADE INCLUSIVITY

The Office of the United States Trade Representative (USTR) has extended the comment period on its "Advancing Inclusive, Worker-Centered Trade Policy" initiative to

# **OFAC SANCTIONS**

·The State Department announced sanctions on eleven individuals and one entity connected with the forcible transfer and deportation of Ukrainian children to Russia and transferring Ukrainian children within Russia.

·OFAC has imposed sanctions on three entities tied to a sanctions evasion network attempting to support arms deals between Russia and North Korea.

·OFAC has <u>designated</u> Green Without Borders, a Lebanon-based organization that has provided support to and cover for Hizballah operations in southern Lebanon while publicly operating as an environmental organization.

#### **CHARITY EXPORT VIOLATIONS**

The Department of Justice (DOJ) has announced that NuDay, a New Hampshire charity, has pleaded guilty to falsely reporting the end destination of shipments as Turkey instead of Syria and falsely reporting values below the \$2,500 Census Automated Export System (AES) reporting threshold, resulting in the failure to execute AES filings.

# SOLAR CELL AD/CVD

Commerce has finalized antidumping and counterv countervailing (AD/CVD) duties on circumvention of solar cell duties. Commerce found Cambodia's New East Solar and Vietnam's Vina circumvented AD/CVD duties. These duties are on pause until June 2024 due to a two-year presidential waiver. 8 8 Fed. Reg. <u>57419</u> (Aug. 23, 2023).

# **BOYCOTT LIST**

The Treasury Department has issued an updated list of countries requiring cooperation with an international boycott. This includes Iraq, Kuwait, Lebanon, Libya, Qatar, Saudi Arabia, Syria, and Yeman. 88 Fed. Reg. 57178 (Aug. 22, 2023).

#### **AES ULTIMATE CONSIGNEE**

The U.S. Census Bureau Trade Regulations Branch has posted guidance on determining the Ultimate Consignee for Automated Export System (AES) filings. The includes examples quidance showing the interaction between Consignee, Ultimate Ultimate Consignee Type, and Country of Ultimate Destination. Contact Sean Murray or Chuck Ballard with questions.

# **EPA HFCs IN ACE**

The Environmental Protection Agency (EPA) has posted an updated version of its ACE Supplemental Guide that includes final guidance on electronically filing hydrofluorocarbons (HFCs) information in ACE. CBP and EPA plan to have the HFC requirements available for testing in ACE in early

Walmart and Centric Brands are reportedly investigating Cambodia supply chains based on allegations of links to women's prison labor.

#### CANADA FORCED LABOR

The Canadian Ombudsperson for Responsible Enterprise (CORE) has <u>published</u> complaints and initial assessment reports on Walmart Canada, Hugo Boss Canada, Diesel Canada, Ralph Lauren Canada, and Gobi Min, detailing allegations of supply relationships with Chinese companies that use Uyghur forced

#### **IPEF AGREEMENT TEXT**

The Commerce Department has published the final text of the Indo-Pacific Economic Framework for Prosperity (IPEF) Supply Chain Agreement. The agreement does not include any duty reductions, but includes supply chain facilitation and resilience efforts, including the creation of three IPEF supply chain and labor rights groups for ongoing

#### **UNVERIFIED LIST REMOVALS**

BIS has removed 33 entities from its Unverified List (UVL) after it was able to complete end use checks. The removals include several Chinese technology entities and universities, along with entities in Pakistan, Indonesia, Singapore, Turkey, and the United Arab Emirates. 88 Fed. Reg. 57002 (Aug. 22, 2023).

# **AES 97H FAQS**

CBP has <u>released</u> a set of Frequently Asked Questions on Automated Export System (AES) "97H" shipment hold notices.

# **BUY AMERICA**

The Office of Management and Budget (OMB) has released guidance on the "Build America, Buy America Act" (BABA). Contact Brian or Sean Murray with Murphy questions. 88 Fed. Reg. 57750 (Aug. 23, 2023).

#### **FCPA**

3M has <u>agreed</u> to pay more than \$6.5 million to resolve charges that it violated the books and records and internal controls provisions of the Foreign Corrupt Practices Act (FCPA). The Securities Exchange Commission (SEC) found that, from at least 2014 to 2017, 3M's Chinese subsidiary Chinese government officials with overseas travel that included guided tours, shopping, sightseeing day trips, and other leisure activities.

#### **SPACEX LAWSUIT**

The DOJ has filed a lawsuit against SpaceX for improperly using export control laws to discriminate against refugees and asylum seekers. This lawsuit follows a \$365,500 DOJ settlement with General Motors over similar claims. This is a nuanced area that requires care. Contact September 29. 88 Fed. #### **OFAC IRAN SETTLEMENT**

OFAC has announced a \$660,594 ANTIBOYCOTT settlement with U.S. building materials supplier Construction Specialties Inc. for Iran sanctions violations by its UAE subsidiary. A whistleblower reported subsidiary illegally reexported more than \$1 million of construction materials to Iran and falsified trade documents to hide the destination.

BIS has imposed a \$48,750 civil penalty against Pratt & Whitney Component Solutions, Inc (PWCS) resolve violations of the to antiboycott provisions of the Export Administration Regulations. PWCS voluntarily disclosed the conduct to BIS, cooperated with investigation, and took remedial measures after discovering the conduct at issue, all of which resulted in a significant penalty reduction.
